**Notice of Ministerial designation of land for community infrastructure under the *Integrated Planning Act 1997***

**A Ministerial designation has been made**

I, Hon Kerry Shine MP, Attorney-General, Minister for Justice and Minister Assisting the Premier in Western Queensland, give notice that under the *Integrated Planning Act 1997*, chapter 2, part 6, I made a Ministerial designation of land for community infrastructure on 8 July 2008.

The designation will take effect from 18 July 2008.

**Description of the land to which the designation applies**

The Ministerial designation applies to land located at George, Herschel and Roma Streets, Brisbane City. The land is described as Lot 12 on SP147396, Parish of North Brisbane, and County of Stanley.

**Type of community infrastructure for which the land has been designated**

The land has been designated for the Brisbane Supreme Court and District Court Complex.

This community infrastructure is described under the *Integrated Planning Act 1997*, schedule 5 as:

- (s) any other facility not mentioned in paragraphs (a) to (r) and intended primarily to accommodate government functions.

Without limiting the extent of the community infrastructure to be delivered at the site, the existing uses and present intentions include:

*"Brisbane Supreme Court and District Court complex, together with ancillary plant, equipment and support services (including emergency power generators), required to allow the community infrastructure to operate for its intended purpose and to service the needs of its occupants and users. The use also includes ancillary commercial services that are in support of the community infrastructure."*
