*State Development and Public Works Organisation Act 1971***GLADSTONE ECONOMIC AND INDUSTRY DEVELOPMENT BOARD (APPOINTMENT OF MEMBERS) NOTIFICATION (NO. 3) OF 2008****Short title**

1. This Notification may be cited as the *Gladstone Economic and Industry Development Board (Appointment of Members) Notification (No. 3) of 2008*.

**Commencement**

2. This Notification commences on 1 July 2008.

**Appointment of members to the Gladstone Economic and Industry Development Board**

3. Under section 113 of the *State Development and Public Works Organisation Act 1971* ("the Act"), Governor in Council, on recommendation of the Minister, appoints –

- (1) the persons listed in Part A of the Schedule; and
- (2) the persons who hold the offices listed in Part B of the Schedule

as a member of the Gladstone Economic and Industry Development Board ("the Board") until 30 June 2011.

**Delegate of Coordinator-General on the Board**

4. For information purposes, under s.113 of the Act, Dr Geoffrey Dickie, Deputy Coordinator-General, the delegate of the Coordinator-General, is also a member of the Board.

**Nomination of Chairperson and Deputy Chairperson**

5. Under section 114 of the Act, the Governor in Council, on the recommendation of the Minister nominates –
  - (1) Mr Leo Zussino, General Manager, Gladstone Ports Corporation to be the Chairperson of the Board; and
  - (2) Dr Geoffrey Dickie, Deputy Coordinator-General, the delegate of the Coordinator-General, to be the Deputy Chairperson of the Board.
